

ENTITY INFORMATION STATEMENT

Structure:

Unite Church is an associated member church of Christian Churches New Zealand (CCNZ), formally known as Associated Churches of Christ in NZ.

Unite Church is body constituted by members (internally; "Partners") who have entrusted oversight to the board. The board currently has six members (two paid employees, four volunteers). The Board governs Unite, overseeing mission, vision and ethos, and setting the strategic direction. It shall ensure compliance with legal requirements, including employment matters and health and safety, etc. It is responsible for ensuring effective financial performance.

Unite uses the words 'membership' and 'partnership' synonymously; partners own the vision and mission of Unite and the climate and activity within Unite.

Partners are members of Unite's legal entity. The following decisions for the local church shall require the approval of the partners by a simple majority of partners present and voting:

- i. amending the functional guidelines, and
- ii. ratifying the annual budget.

For more information, request to view Unite Church's Functional Guidelines, adopted by partners on 28th August 2016, on file with the church office.

Main Source of Cash:

Unite Church's main source of cash are donations (internally; tithes and offerings) from Partners and "faith family."

Main Methods used to raise funds:

Other than the tithes and offerings received from Partners; minor hall & facilities hire, residential rent, and external funding applications also contribute to funds raised.

Unite Church has, in the past, encouraged it's members to give into an "Extravagant Offering" event to support funding an asset, development or activity apart from the normal or above budgeted expenses, although this didn't happen in this past financial year reported here.

Reliance on volunteers and donated goods and services:

Unite Church relies on volunteers to fulfil its purpose.

Some examples of this include:

- The governing board has four out of it's six members volunteering
- The Executive Team (the ministry team that leads week to week into our future, in alignment with direction provided by the Board) includes volunteers
- All ""Dream Team"" members serving on a team every Sunday (approximately 30 people each week) are volunteers - ranging from being on band, making coffee and serving morning team, caring for and welcoming visitors, leading the childrens church, involved in production and tech teams.
- All Life Group Leaders, hosting a small group of church members in their home each week, are volunteers (approximately 15 volunteers).
- Unite Church is thankful for the range of discounted goods and services it also receives.

Additional Information:

2019 was the first year with it's new Senior Leaders, Elijah & Karen Burton, and therefore has been transitioning some of it's structures, a process that is expected to continue into 2020.

SERVICE PERFORMANCE STATEMENT

Outcome Description:

Unite Church's outcome is to be a home (a body of people) built on Christ, where people have opportunities to meet Jesus (in our Sunday Services and events), be transformed together (in Life Groups), and who shine as God's family in every sphere of life (in Dream Teams and other).

Description and Quantification of the Outputs:

Below were the "Health Indicators" (Measurable outputs/goals) set by Executive Team and approved by the Board at the beginning of 2019.

Stories	 Connect cards were an effective tool being regularly handed in with stories - an estimated average of at least 2-3 a week. Connect card praise stories and prayer requests being read out on Sunday's regularly, and discussed/prayed over at ET meetings. Themes were also effective in encouraging specific stories being shared from family relative to the theme. Most Sundays had at least and shared in encouraged.
Leadership	 least one story being shared. Approximately 25-30 people took on a new mantle of leadership over 2019 - whether in Next Gen, Team or Life Group leading, or even responding to a leadership call outside of Unite Church in the wider church body.
Prayer	 Jenni Ball led our Sunday night prayer meetings for much of 2019 covering many people and topics in prayer.

Board Chair:

Writing as I am from the fog of NZ's 2020 COVID-19 lockdown in the middle of May, I find it difficult to cast my mind's eye all the way back to 2019. But it is starting to come back into focus. The highs and lows of participating in a church community, set against the backdrop of a constant and faithful God. As ever, He has been so, so good to us.

2019 was my first year as board chair, and Elijah and Karen Burton's first year as Senior Leaders. We accepted Pat Todd's retirement as Church Treasurer. Pat has held this official post for over 15 years, and together with Graeme assisted the previous treasurer for many more. Pat has faithfully served the people and mission of Unite Church by keeping the books in order, year after year. 2019 was no exception. We are so very grateful for Pat's service to us over so many years, and look forward to seeing her continue to be a blessing to us in other ways, in coming years. We love you so much, Pat!

The church has benefitted hugely from a decision the board made in late 2018 to employ Dani as Associate Leader, and from having Adan Soroka serve as an intern overseeing our youth ministry, a position funded through Bishopdale Theological College. We are equally grateful for the multitude of ways that ALL of our church family have contributed to community life over the year. It is an increasing conviction of the leadership team that God has deposited gold into each of his children, and it is the task of leadership to help see ALL of this gold shine and be shared, to the glory of God. Thank you for sharing your gold with us.

COVID or no-COVID, we look out to an ever-changing world, particularly here at home where NZ society seems increasingly hostile to Jesus and His church. Executive Leadership Team:

Many people ask me what our Executive Team did last year. My answer... everything!! In all seriousness, our Executive Team was the hands-on leadership of Unite. This team consisted of Karen Burton, Dani Montauban, Kirsten Burr, and later in the year, James Hodgson. We oversaw Dream Teams (volunteers), Life Groups (small groups), Sundays (services), Next Gen (children, intermediate, youth), and Pathways (Next Steps). In addition Karen and I oversaw Prayer and Culture, Dani our Associate Leader oversaw our Administrative Oversight and Volunteer Staff Team (and being all round incredible at creating and managing systems and structures), and myself leading this team and filling in gaps as needed.

Our Services and Dream Teams were managed by our Volunteer Staff Team, under the leadership of the Executive Team. We saw monthly themes creatively and powerfully executed, with many incredible stories of God's goodness, and many new people come to know Jesus.

Our Life Groups were overseen by Karen, who began a stronger process of support via reports and coaches. These coaches were Karen, Kirsten, and Brian Munro. This was the first step in seeing something new develop this year, as we believe that smaller groups of Unite need accountability that develops from trusted relationships. Last year's reporting system helped us to see this. Church is not grown from a collection of individuals working next to each other, but from a family of people working together closely, deeply devoted, and committed to each other as they are committed to Christ.

Our youth was led by Adan Soroka with a small group of interns: Max Patterson, Mikey Swift, Suzie Olive, and Joy Gutschlag, and was overseen by myself. We saw a small group of youth grow closer together, with the interns growing in faith and community.

Our children's ministry was led by Karen, with Shaun and Celeste Coles leading our intermediate ministry, and Joy running crèche (and later on Scott Montauban). Themes created a great opportunity for children's ministry to grow alongside our regular Sunday services.

A regular prayer service was led by Jenni Ball. The group changed in size but was consistent in purpose. I loved working alongside Jenni, and seeing her heart for Nelson, New Zealand, and the world.

As I think back over last year I can't help but feel that one of the most valuable things to come out of last year was the relationships. God knew what He was doing in putting us all together. The trust developed over the months has led us to the type of devine conversations and prayers that make me so so excited for what Jesus is doing in us and through us to the world. MISSIONS OUTREACH REPORT December 2019

Each week as our partners give to Unite Church, 10% is taken out to support groups and individuals carrying out the "great commission" to extend God's kingdom both in New Zealand and overseas.

Pastors Support Zimbabwe

Pastor Reuben Sithole

For the past 20 years, Zimbabwe has been a troubled nation both politically and economically. Kiwilink is not able to help everyone but we have a group of around 30,000 people we are helping in rural South Western Zimbabwe.

Chris Baigent (KiwiLink Zimbabwe) says "Thank you again for supporting Pastor Reuben Sithole and his wife Alletta with your finance and prayer. The money you provide pays their salary and helps to support their three children aged 10 to 20 years. They Pastor a group of four churches in the Mabvazuva Circuit. Each of the Pastors have at least one Church plant under way and as the circuits grow, they are divided and a second Pastor is brought into the area. This particular area is spiritually strong and the long established church at Gwenombe was the foundation church of that area. Pastor Sithole has a pastoral heart and is well liked by the people. He is a powerful singer and writes his own music. It is always a pleasure to have him share a song when visitors are in his area."

Kiwilink Vanuatu

Sue & John Cunningham and Bev and David Todd

During this past year Kiwilink Vanuatu has been able to continue to support the Churches of Christ in pacific island country of Vanuatu. Unfortunately we were not able to send a team due to other commitments of team.

The Bombua School on Santo needed extra buildings due to the Londua Technical School relocating there because of evacuation as a result of the volcano erupting. We sent a gift with Steve Rollo and Ron Bergman which they gave to this school to help finish the roof.

The support of Pastors is a continuing ministry we have done this past year. Ni-Van's strive to learn and pastors want to attend Bible college training. This past year we paid for their training fees and also monthly allowances so that the family is supported while the father trains.

CCNZ Mission Development – Jesus Revolution

Brent Liebezeit, President of CCNZ writes:

Thank you for your generosity to our CCNZ movement.

As you may be aware the usual levy that is paid by our churches covers our general administration and our mission development fund helps towards what we call our Jesus Revolution project.

This project has been focussed primarily on resourcing and empowering our Pastors and leaders. The last 12 months Unite Church has helped CCNZ again by enabling CCNZ to be missional rather than just administrated.

Your contribution has gone towards

 Our Pastors Retreat, where our Pastors and key leaders are given an opportunity to be together for a few days for input, connection and time out from the busyness of ministry. Evident program which is a weekend together with our churches potential ministry leaders often held at Bethany Park Kaiteriteri. This has provided an environment for those who attend to receive vision and teaching that is focussed on empowering attendees to be better leaders for their local church.

The Pastors of the churches that contribute to our missional development fund are given free registration to these events.

Jonathan & Meredith Thorpe – International Student Ministries Nelson.

In 2019 we continued to see many lives touched through the work of International Student Ministries in Nelson. A highlight was taking a group of believers and seekers to Christchurch for a regional camp which Jonathan helped to organise. Jonathan provided supervision for an intern each from Annesbrook Leadership College, and from Bishopdale Theological College.

Leadership for Unite International (a weekly Thursday evening event for internationals, at Unite church), and Operation Friendship (Bigger Saturday events for the international students, enabling us to meet and offer Christian hospitality to a large percentage of the international students who come to NMIT) These two programmes have functioned very effectively.

We have also had a Discipleship Life Group, and Discovery Bible Studies running throughout the year, with some great success among some of the Japanese and Chinese students who have been hungry to hear about Christian faith.

Jonathan (with the help of Jean Coyle, Michael Chapman and a few others) manage Haven-on-Grove, Palm Haven and Unite Community Flats. They have been mainly full, and these offer a home away from home for so many international students. It is not always easy in the flats with many cultures, and faiths. If any of you are interested to play a part in creating and or maintaining these homes as a safe haven where the spirit of Jesus reigns, then do talk with us

Thanks to all of you who have helped out this last year in this area of the Lords kingdom.

In 2020 Jonathan and Meredith are taking a year out from living in Nelson to focus on assisting on Jonathan's families' farm, which is currently in transition, although we still enjoy participating in a Unite Neighbourhood group. Jonathan still does part time ISM work, alongside farming and therefore only takes part of his financial support from ISM. Any surplus donations are being put towards other related ISM work that Jonathan is still connected with. ISM ministry continues in Nelson with our volunteer team and via online zoom, and social media.

Radio Rhema

Christian radio has been broadcast for over 40 years here in New Zealand. Rhema Media have 3 radio stations (Rhema, Life FM and Southern Star) one TV channel (Shine TV) and the Word for Today all sharing the gospel in various ways to the full cross section of NZ society. There are many testimonies of lives changed, hope renewed and purpose in life.

Marty Scheib – OAC

During this past year Marty has continued his very effective work of brining the message of Jesus to children and adults through open airs, school assemblies, prisons, church programmes and other outreach programmes.

Based in Christchurch, he presents at many schools and churches in Canterbury region but also travels to Quinney's Bush and recently went to Fiji along with a team from OAC.

Pip & Paul Etherington

Pip & Paul have been Bible translating for the Nggem people in Papua for many years. Pip grew up here at Unite and trained as a nurse. After marrying Paul they felt Gods call to missionary work in translation with Pioneers New Zealand. They have been through difficult times but are seeing lives changed once the people hear God's word and love for them.

Elders Outreach

The Board have been able to provide support to those in the church and community as an unexpected or urgent need arises.

Basis of Preparation:

Unite Church has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Goods and Services Tax (GST):

All amounts are recorded exclusive of GST, except for Debtors and Creditors which are stated inclusive of GST.

Income Tax:

Unite Church is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts and Cash:

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Changes in Accounting Policies:

There have been no changes in accounting policies during the financial year (last year - nil)
